

# JOB DESCRIPTION

Position: Psychiatrist

#### **GENERAL PURPOSE:**

Under general supervision of the Chief Medical Officer, the Psychiatrist is responsible for evaluating, diagnosing and treating patient with mental, emotional, and behavioral disorders. The Psychiatrist will conduct thorough evaluations, develop treatment plans, prescribe medication and evaluate treatment results.

#### MAIN RESPONSIBILITIES & DUTIES:

- Assess and screen patients by conducting psychiatric evaluations, including interviews, medical histories, physical exams, observations, and psychological testing
- Analyzes data and results of assessments to diagnose patients
- 3) Thoroughly document patient's diagnosis, symptoms, medical and treatment effectiveness
- Develops comprehensive treatment plans, measure progress against the plan, and make adjustments as needed
- 5) Prescribes and administers medications according to diagnosis
- 6) Monitors patient to determine efficacy and potential side effects of medications
- 7) Consults with other medical professionals and psychologists
- 8) Provides patients with emotional support and strategies to help manage their disorder
- 9) Supervises and directs family nurse practitioners, physician assistants and other mid-level providers
- 10) Other physician duties as assigned by supervisor

#### **QUALITIES & CHARACTERISTICS:**

- 1) Maintains a professional relationship and positive attitude with co-workers the public, patients and all Ampla Health staff, Board of Director and vendors
- Maintains the highest professional ethics and is honest in dealing with people; is a model for all employees through his/her actions
- 3) Strives to learn more and is receptive to learning different ways of doing things
- 4) Displays enthusiasm toward the work and the mission of Ampla Health

## PROFESSIONAL KNOWLEDGE, SKILLS & ABILITIES:

- Must hold MD degree from an accredited medical school and completion of an approved Psychiatric residency
- 2) Must be Board certified or eligible in Psychiatry
- 3) Must have completed and approved internship
- 4) Must hold a valid California State Physician and Surgeon License
- 5) Current CPR certification
- 6) Current DEA license
- 7) Must be sensitive to the corporation's diverse patient population
- 8) Demonstrate clear knowledge of Ampla Health's clinic structure, standards, procedures and protocols

#### **COMMUNICATIONS SKILLS:**

- 1) Must have neat and legible handwriting
- 2) Must be able to interact with patients, vendors and co-workers courteously and calmly
- 3) Ability to communicate well with the public

### **WORKING CONDITIONS & PHYSICAL REQUIREMENTS:**

Works well with patients, co-worker and vendors in a generally comfortable environment office. Employees must possess the following physical requirement:

- Must be in good health and able to lift up to 40 lbs and push up to 100 lbs (on wheels)
- 2) Must be able to work on feet the majority of the day without tiring
- 3) Must be able to hear adequately to auscultate B/PS
- 4) Must have vision which is adequate to read increments on tuberculin syringe accurately
- 5) Must have high manual dexterity and tactile sensation on fingertips
- 6) Must be able to reach above the shoulder level to work, bend, squat and sit, and twist/turn
- Routinely exposed to blood borne pathogens and may be subjected to verbally and/or un behavior patients
